Most bills and expenses have been already paid for the 2020-21 competitive gymnastic season.

Medals \$17,000

Apparel paid in full for 70% of gymnasts

Equipment \$45,500 held over to next year. Deary's equipment offered to carry over the 2019-2020 equipment rental fees to the 2021 State meets. Deary's truck rental fees will go up next year due to increased expenses to Deary's.
